Summary Description and rationale of project and funding sources:									
<p>The bandshell was installed in the 1980's and has received very little updating since construction. The structure does not meet ADA access standards, the roof is 50+ years old and is in need of replacement. The electrical system is also in need of updates to bring it up to code. The neighborhood has requested outdoor fitness equipment be added to the park. There are many residents in the neighborhood that utilize the park for daily exercise and this equipment would be well utilized. The existing tennis court is in need of resurfacing. In addition, the basketball court is in need of reconstruction due to age with severe cracking and deterioration. Restrooms are in need of updating to ensure a positive user experience as they have exceeded their life expectancy. The intent after completing Bonner Bandshell upgrades is to use remaining funds to update existing restrooms pending approval. An anticipated balance of funds after lighting improvements is project to be \$23,000.</p>									
History & Current Status: Impact if Cancelled or Delayed									
<p>Bonner Bandshell ADA access ramp was designed in kind by a local architect in 2020. The ADA access improvements were partially funded by a private donation. ADA ramp construction was completed in Autumn of 2023. In addition, bike racks were funded through a neighborhood grant and installed with Parks and Recreation support. Roof Replacement was completed in December 2024 with light fixture upgrades to be complete on or before July 2025. Parks Operations completed electrical upgrades to the GFI outlets and panel as need in 2023. Additional building storage to the bandshell is no longer requested (May 2024). In addition, a drinking station/water-bottle fill station was installed between the splash pad and playground to replace the failed drinking fountain by the restroom. Additional park improvements to complete and fund are outdoor fitness equipment, sport court reconstruction and tennis court resurfacing. In 2023 the basketball court was crack-filled and seal coated along with 5 other basketball courts in the system. Lighting upgrades will be funded (\$14,148) with the remaining balance of funds for Bonner Bandshell improvements. Portable pickleball nets were removed from the tennis courts with the 2024 winter closure of courts and not replaced in the spring due to pickleball noise complaints.</p>

Delayed park maintenance and or improvements will contribute to further deterioration and added costs for maintenance. Project costs will increase over time if not funded.
