Summary Description and rationale of project and funding sources:									
<p>Fort Ponds historically operated as an open pit aggregate mine since the 1950's. Prior to mining operations stopping in ~2015, Knife River/JTL Group, owner/operator at the time offered the land to the City of Missoula for the benefit of the public. The site was donated to the City of Missoula on November 24, 2020 after meeting DEQ requirements for remediation and closing out Knife River's Bond on September 20, 2019. A substantial amount of work remains to safely open the site to the public and balance the site's ecosystem with appropriate recreation. To protect mining operations, an artificial riverbank constructed of waste concrete and overburden was established along the Bitterroot River's western edge, eastern edge of the Fort Missoula Ponds parcel that filled a historic forested riparian area and established an artificial river bank. To date, the artificial river bank is subject to erosion. Spring of 2024, Parks and Recreation staff applied for funding from the RDGP planning grant program to fund planning/design to correct the failing Bitterroot River bank and restore a filled historic forested riparian area that was the result of aggregate mining. April 2024 a \$75,000 RDGP Planning grant was awarded to the City of Missoula. Parks and Recreation funding commitment is a cash match \$13,149 to be funded by Park Impact Fees: Project Contingency 10% (\$8,014) and toward task 5 of the Grant, Design Development (\$5,135). As per the grant application the project listed a start date of April 2025 with a April/May 2026 completion.</p>									
History & Current Status: Impact if Canceled or Delayed									
<p>The site is currently closed to the public but trespass onto the property increases every year. User made trails, beach access and vandalism has greatly increased on the property. The longer the City takes to proactively manage recreational access on site the more resource damage and irresponsible recreational trends will develop. Multiple funding opportunities for site development/improvement/restoration exist. Despite a history of significant disturbance due to open pit aggregate mining, five (5) main habitat types exist across the parcel: Upland grassland, Freshwater pond, Freshwater emergent wetland, Riparian emergent wetland, and Riparian forest. The goal is a community supported master plan that balances the parcels ecosystem health and appropriate recreation. A master plan will strengthen the City of Missoula's ability to leverage funds for implementation, prioritize work and address site needs with the goal to open the site to public access. Parks and Recreation will have a consultant secured in FY26 for design and engineering services. The intent after design and engineering, is to apply for a DNRC project grant for construction. Funding request for unappropriated subsequent years is intended to be used as a grant match for project construction / implementation.</p>
