Summary Description and rationale of project and funding sources:									
The City Hall roofing system has outlived its lifespan by nearly a decade and has been patched and repaired multiple times by the Facilities staff. This CIP would clean repair and apply a seal coat to the existing roof system. The coatings carry a 20 year warranty. The coating process cost is @ \$5 per sq.ft. a reroof could be 12 to 15 dollars both offer the same life expectancy. The County coated the courthouse roof after the remodel and it has been trouble free.									
History & Current Status: Impact if Cancelled or Delayed									
The roof membrane is degrading Facilities staff check for issues weekly. We need to replace or coat this roof before we have water infiltration into City Hall. We can still get ahead of this and save a total reproof, but if we continue to wait we may loose the option of adding a coating to the existing membrane.
