

## Resolution 8905

A RESOLUTION OF THE MISSOULA CITY COUNCIL AMENDING THE CITY'S DEVELOPMENT IMPACT FEE SCHEDULE TO IMPLEMENT CHANGES TO MONTANA CODE ANNOTATED TITLE 7, CHAPTER 6, PART 16 AND TO REMOVE CERTAIN IMPACT FEES FROM THE SCHEDULE.

**WHEREAS**, during the 2025 Montana legislative session, the Montana Legislature passed SB 133, an act revising local government impact fee laws, including the removal of administration fees and changes to the definition of public facilities; and

**WHEREAS**, the City of Missoula seeks to bring its impact fee structure into compliance with the updated state law.

**NOW THEREFORE BE IT RESOLVED** that the Missoula City Council adopts the updated fee impact fee schedule reducing certain fees as shown in Exhibit A effective October 1, 2025
