

ORDINANCE NUMBER 3776

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MISSOULA AMENDING SECTION 10.54.140.A(3) OF THE MISSOULA MUNICIPAL CODE (MMC) ENTITLED PENALTIES – PARKING VIOLATIONS, TO ALLOW FOR AN INCREASE IN PENALTIES FOR DISABLED PARKING VIOLATIONS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MISSOULA THAT SECTION 10.54.140.A(3) OF THE MISSOULA MUNICIPAL CODE (MMC) ENTITLED PENALTIES – PARKING VIOLATIONS BE AMENDED AS FOLLOWS:

SECTION 1

10.54.140 Penalties -Parking- violations.

A. * * *

3. Disabled Parking Violations on public or private property. As provided by Montana state law governing disabled parking, violations are penalized as follows:

- a. Each offense, one hundred dollars (\$100.00) For the first violation, one hundred fifty dollars (\$150.00).
- b. For the second violation, two hundred fifty dollars (\$250.00).
- c. For the third and subsequent violations, five hundred dollars (\$500.00)
- d. A person who violates MCA § 49-4-302(2) or (3) may not be fined if within 3 business days the person produces a disability parking permit that was previously issued to the person and that was valid at the time of the parking violation.

SECTION 2

Nothing in this ordinance shall affect or supersede the amendments to MMC § 10.54.140 enacted in Ordinance 3772 on June 2, 2025.

SECTION 3

Severability. If any section, subsection, sentence, clause, phrase or word of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The Council hereby declares that it would have passed this ordinance and each section, subsection, sentence, clause, phrase, and words thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, phrases or words have been declared invalid or unconstitutional, and if for any reason this ordinance should be declared invalid or unconstitutional, then the remaining ordinance provisions will be in full force and effect.
